B. Experience

APS' principals have decades of experience working on behalf of public, private and non-profit clients, including public and private colleges and universities. APS recognizes that Wayne State University has been the anchor of the City of Detroit for many years. Despite the recession, budget deficits and the recent appointment of an emergency city manager, Wayne State University continues to grow and is well positioned to raise its profile nationally as it has successfully done regionally by becoming a major landowner in Midtown: Phase I of the South University Village District was heralded as the local development of the year by Crain's Detroit Business and the announcement of Phase II is indeed worthy of National recognition. In addition, spinout companies for WSU are applying to the federal Small Business Innovation Research program to fund their different approaches to maintaining roads and bridges. Wayne State is ranked by the Carnegie Foundation as among the nation's top 2.3 percent of universities with very high research activity. These distinctions derive from creating the renowned business incubator; Tech Town, the University Research Corridor partnership, and the highly celebrated award of the Eunice Kennedy Shriver National Institute of Child Health and Human Development second 10 year contract to continue housing the Perinatology Research Branch (PRB), research areas of interest to a number of Federal grant opportunities.

Such distinctions provide opportunities to expand potential partnerships with the Department of Energy, the Small Business Administration and NIH, with a primary focus on WSU's experience in both basic reach and technological development.

In the near term, the outlook for state higher education institutions is the same as for most other entities – bleak, but not impossible. On the positive side of the ledger, the Obama Administration and a more innovative- results driven Congress seem determined to open new and potentially landmark avenues for public research urban universities, such as Wayne State University, to succeed and secure necessary Federal support. The challenge for Wayne State, and its government affairs representatives, is first to use these new opportunities to weather the current financial storm and, second, to position the University to thrive as the economy improves.

Our past clients demonstrate our understanding of the types of issues that impact WSU. With our experience, our goal is to bring appropriate federal resources to the table to help WSU achieve its legislative and regulatory goals.

Among the most recent work performed on behalf of our Community College and University clients are:

- Dillard University, New Orleans, Louisiana Just prior to the devastation caused by Hurricane Katrina and under the leadership of Dr. Michael Lomax, Dillard University was in the process of enhancing programs such as teaching and nursing and making substantial investments in critical infrastructure. Working with Dr. Lomax and his team, Andy Garfinkel helped develop the concept for Dillard's International Center for Economic Freedom and worked with the Louisiana congressional delegation to obtain nearly \$2 million in targeted Department of Education Fund for the Improvement of Postsecondary Education (FIPSE) grants. Despite enormous setbacks due to the hurricane, the Center has been highly successful at attracting students to Dillard's exceptional programs.
- St. Norbert College, DePere, WI SNC has been listed in the top ten liberal arts colleges in the Midwest by U.S. News & World Report's guide to <u>"America's Best Colleges"</u> since the guide's inception in 1987. This year, for the first time, St. Norbert was ranked as a national liberal arts college. St. Norbert College was awarded \$910,000 in FY2009 through the Omnibus Appropriations Act for an initiative to prepare students in science, technology, engineering and math (STEM) fields. Congressman Steve Kagen, M.D. and Senator Herb Kohl worked with College leaders to secure funding for this important initiative. APS Principal Andy Garfinkel was instrumental in advancing this STEM field funding by working with the delegation, preparing a case statement for the project, and working with congressional staff to prepare the necessary grant requirements. The federal funds allocated to St. Norbert College was used towards instructional technology,

laboratory equipment and instrumentation, laboratory and classroom furnishings, and science discovery center supplies.

- Metropolitan Community College of Omaha, Omaha, NE Our team, had a unique opportunity to work with this 100,000 student commuter campus community college in the Fort Omaha area of Nebraska. In addition to developing a comprehensive government affair strategy as a short-term initiative for the College, our team also identified a strategic partner for a high priority neighborhood redevelopment project for the campus. Our team brought in a nationally renowned historic preservation developer who we assist with Low-Income Housing Tax Credits, Historic Tax Credits, and other grants sources to advise MCC on the redevelopment project.
- Alverno College, Milwaukee, WI Our team worked with the President, Vice President of Academic Affairs and Faculty of Alverno College, a highly rated teaching and nursing college in Milwaukee, Wisconsin, to develop priority funding initiatives during fiscal years 2008 and 2009. - YWCAs of New York State. Worked with the YWCAs of New York State to enhance programs that support the YWCA's mission of eliminating racism and empowering women. In particular, Andy and his team promoted funding for child-care programs that enable teen mothers to attend school to work and for abused women in transitional housing to develop workforce skills. Andy introduced the YWCA's leadership to the New York State delegation and helped establish program and project priorities based on funding availability.

This work led to successes at the Department of Housing and Urban Development. The Presidential Transition Team created a taskforce of high-level stakeholders that

created a policy guidebook for HUD's new secretary. The guidebook includes a number of USU's recommendations for strengthening urban university-community partnerships.

California State University, Monterey Bay --Worked to secure high level meetings with California Senators and DOE, NSF and Department of Education officials regarding EPA issues.

D. Approach

APS will work with the University to develop a strategy to achieve success in reaching your legislative objectives. We will represent the University before Congress and the Federal Executive branch and agencies while specifically fostering solid relationships with members of the Michigan Congressional delegation. Through APS' Strategic Partner Newton Dillard Inc. and through the FedState Network and our affiliate Michigan partner Kelley Cawthorne, we are able to spend less time building and more time fostering important relationships with members of the Michigan Congressional delegation. Our services will be custom designed to meet the specific needs of WSU: we avoid cookie-cutter government affairs strategies. We develop and implement strategies that match specific needs with the political and policy interests of key lawmakers and Administration officials. We work to develop in-depth background knowledge of the sensitivities, philosophies, and policy objectives of both the lawmakers and our clients.

Our approach to lobbying and advocacy has been tested and proven by time. The following section contains descriptions of how APS will work with you to help identify priorities for Federal assistance and the methods that will help capture the needed funds. For APS, strategy development is a key factor in achieving results and it requires maximum communications with the client. APS provides planning and up-front counseling to maximize the client's opportunities for success. It is vitally important to develop a clear understanding of program objectives prior to presenting any projects to the Michigan Congressional Delegation or a Federal agency. Without this, the effort is immeasurably more difficult and problematic. Thereafter, we will assist in creating a framework for pursuing Wayne State's Federal agenda. This advice and planning process is an intensive, ongoing effort, and we are in contact with our clients on a frequent basis.

APS will immediately immerse itself in WSU's interests and priorities. The APS team will partner with WSU's government affairs Washington office to examine the University's needs. APS will work with relevant faculty and researchers to identify the University's existing assets that can be leveraged to enhance Wayne State's probability of success at the federal level. Typically, APS suggest a site visit and in-person meetings in order to best complete this initial inventory. If time does not allow for a visit, an effective inventory and discussion can also take place via teleconference. Given that our team is familiar with the University, we envision a smooth transition into the next phase of the assessment.

We are adept at securing federal funding for clients and can help elevate the University's interests with federal officials, the Michigan congressional delegation, and Department of Education officials and our Michigan partner, Kelley Cawthorne, can provide the needed state support and lobbying services WSU requires.

As part of the federal grant process, APS communicates with private, local, regional and state executives and community leaders to obtain written support for initiatives and we provide continuous legislative and grant monitoring throughout the consideration process. We work as an extension of WSU staff to Members of Congress in order to help communicate the University's concerns and policy objectives.

We perform all of these tasks on a consistent, daily basis to ensure the success of priority projects. By clearly defining our mission and scope of work on behalf of our clients, we can achieve specific benchmarks of success until the project is complete. Some of the ways we propose to assist WSU include:

- Identify high value competitive and non-competitive grants;
- Work with the community to pursue federal economic development resources with the aim of enhancing WSU's profile regionally, nationally and internationally;

- Work to reverse the deep cuts in funding to the Department of Education in the FY 2013 Labor-HHS- Education appropriations bill;
- Assist WSU staff with the development of a strategic government affairs plan;
- Obtain intelligence on competitive grants;
- Write or support the development of grants, including all administrative processes for pursing federal and other grant opportunities;
- Develop case statements that increase the likelihood of success for all grant applications;
- Identify legislation that supports increased opportunities for WSU and its students;
- Utilize APS' relationships within the Michigan delegation to further increase WSU's profile in the State;
- Secure a Congressional champion or champions to advocate for WSU's goals in Washington, DC; and,
- Identify and pursue opportunities for WSU with various agencies of the federal government.

Grant Support

APS and the Newton Dillard Inc. team understand WSU's priorities and development interests. We regularly monitor and seek out new opportunities for university leadership, faculty and students to pursue competitive grant funding assistance, and we directly support grant-writing activity. Our team has a successful track record in grant writing, but typically provides this support on an as-needed basis for high priority initiatives. We are always available to provide insights on grant submissions and to review individual grants to provide direction that may enhance the strength of a particular submission. Some of the areas that we believe should be prioritized for grant support within the WSU system include:

W Teacher Education and Training

WSU has a long and highly developed history of teacher education and we recognize that identifying funding opportunities in this area is critical to supporting and sustaining the College of Education at WSU. Not only is this issue critical to the University, but to the Detroit public education system.

The Presidential Teaching Fellows Program

The TEACH Grant program is proposed to be replaced in the budget request by a Presidential Teaching Fellows program (PTF). This proposal was first made in the FY2012 budget request. PTF, funded with mandatory spending, would provide grants to states to award scholarships of up to \$10,000 to individuals who attend high-performing teacher preparation programs and commit to teaching in a high-need school. Our team would work with our State Partner to monitor and track State legislative initiatives.

Our team typically seeks current grants as well as identifies grant histories in various program areas. With substantial cuts to the Department of Education's Fund for the Improvement of Post Secondary Education (FIPSE), we can help WSU identify funding priorities and pursue funding in areas where the College may not have participated in the past.

Some of the traditional grants currently available include:

- Research Experience for Teachers (RET) in Engineering and Computer Science
- NIH Summer Research Experience Programs
- Fulbright-Hays Group Projects Abroad Program
- Faculty Early Career Development (CAREER) Program
- Education and Special Programs (National Science Foundation)
- Office of Innovation and Improvement grants
- Institute of Education Sciences (IES): Education Research
- Minority Science and Engineering Improvement Program

We provide guidance to faculty and researchers as needed. We also identify outside partners, including foundations to support targeted development areas.

Our team is keenly aware of WSU and the School of Medicine's interest in continuing to build excellence in the fields of brain mapping, prenatal research, and nursing. We identify new opportunities and work with faculty and university leadership to steer projects into funded areas of research and education. We offer examples below:

Traumatic Brain Injury and Brain Disease

Wayne State University and the School of Medicine has developed expertise in the area of brain imaging, particularly related to traumatic brain injury. Our team is able to identify and pursue relevant funding opportunities in this field in coordination with WSU School of Medicine.

There are currently multiple competitive grant opportunities available in this area such as:

- DoD Psychological Health and Traumatic Brain Injury Traumatic Brain Injury Research Award
- Establish Sharing of Human Brain Image Data Relevant to Drug Addiction (Admin Supp)
- Collaborative Research on Chronic Traumatic Encephalopathy and Delayed Effects of Traumatic Brain Injury: Neuropathology and Neuroimaging Correlation (U01)
- Lab to Marketplace: Tools for Brain and Behavioral Research (SBIR [R43/R44])
- Biobehavioral Research Awards for Innovative New Scientists (BRAINS) (R01)

In addition, President Obama recently announced a federal brain mapping project as part of his proposed FY2014 budget. This initiative seeks to conquer diseases of the brain such as epilepsy, autism and Alzheimer's disease. This highly anticipated research initiative could provide an opportunity for WSU to engage in directly with the White House and Congress

Prenatal Research

The National Institutes of Health and the Health Resources and Services Administration offer numerous opportunities to participate in research and education in the field of prenatal medicine.

Current and recent initiatives include research in the areas of:

- In Utero Alcohol Exposure on Adult Health and Disease
- Pregnancy in Women with Disabilities
- Early Childhood Comprehensive Systems: Building Health Through Integration

>> Nursing

Similar to opportunities in prenatal research, there are consistently new grant opportunities for nurses participating in research and nurse education. Some of these include:

- Research on Emergency Medical Services for Children
- Obesity and Asthma: Awareness and Management
- Healthy Behavior in Children and Adolescents
- mHealth Tools to Promote Effective PatientProvider Communication
- Practical Interventions to Improve Medication Adherence in Primary Care
- The Influence of the Microbiome on Preterm Labor and Delivery
- Etiology and Pathophysiology of Sleep Disordered Breathing in Pregnancy
- DoD forward Surgical En Route Care

• Scholars Training for the Advancement of Research (STAR): only open to NINR T32 Training Grants

Our government relations team will identify unique opportunities in targeted fields to increase opportunities for nurses training at WSU. We recognize the challenges of providing scholarships and expanding new opportunities for young nursing students and supporting faculty research opportunities.

The APS/Dillard team has decades of experience supporting grant writing and writing grants. In addition to working on successful targeted FIPSE grants for clients such as Dillard University. We more recently have participated in competitive grant awards. Two recent successful grants include a community development investment award of \$600,000 and an environmental remediation award for a contaminated brownfield and creek for over \$1 million. We welcome the opportunity to work with WSU's leadership, faculty and students to enhance its grant writing capabilities. Initially, we would seek to establish a baseline to determine current revenue from competitive grants and then seek to raise revenue above this baseline as one measurement of our success on behalf of WSU.

We are confident these government affairs services and priority initiatives as well as any others WSU may wish to pursue will add significant value to WSU's overall strategic and revenue goals.

The APS Team will work with both the elected and appointed officials in Michigan to develop a strategy to achieve success in reaching WSU's Federal and State objectives. This Team has very strong relationships with the key policymakers, decision makers and elected officials within Congress, the Administration and the Michigan Legislature. It is our belief that we can utilize these relationships to cooperatively develop the mechanisms that should be utilized for accomplishing the goals of our clients.

We have the capability and the resources to effectively present and represent WSU's legislative strategy to Representatives, Senators, the Executive Branch and State Agencies in a direct lobbying effort on behalf of the University. We also have close ties to the Governor's Office and have maintained a strong relationship with the leadership of the majority and minority parties in both houses, Federal and State.

Our Team is intimately aware of the impending legislative issues that affect WSU. Programs of interest and potential opportunities include:

- Healthcare is an important focus for Wayne State University. To meet the projected shortage of public health professionals in the State of Michigan, Wayne State was awarded an Area Health Education Center (AHEC) grant in FY 2012. Funding for AHEC grants are currently uncertain; under the FY2014 budget, the basic health professions training programs have been cut by \$37 million since FY 2010- and that is in actual dollars, before any adjustment for costs or need. Discretionary appropriations for health centers are down \$623 million 28 percent- since FY2010. Under such difficult budget decisions, the Obama Administration contends that many of the HRSA programs will be folded into the implementation of the Affordable Care Act. There is evidence that both the House and Senate Labor Health and Human Services Committees support HRSA programs and expect urban and rural institutions of higher education to be proactive in their support of increased funding. Although Senator Stabenow is not a member of the Appropriations Committee she is a staunch advocate of Community Health Care Centers and AHEC. APS can assist to get their voices heard by helping to write letters of federal officials and local media outlets. In addition, Representative Dingell serves as an important ally on the Energy and Commerce Committee.
- Alternative Energy Technology is another important issue area for WSU. In 2011, the College of Engineering experienced a record-breaking \$21.8 million in research awards from grant-funding agencies and organization, particularly in certain standout areas such as advanced vehicle propulsion systems, alternative

energy technology, nanotechnology and biomedical engineering. At the same time, Wayne State is a partner of the University Research Corridor. These issues match well with Federal interests.

Climate change and energy conservation are priorities for the Obama Administration and Congress, leading to a significant investment in related research. Under the President's FY2014 proposal, funding for the Office of Science at the Department of Energy would increase by 5.7 percent as compared to the FY2012 enacted appropriations. This requested funding increase is significant because of the intense pressure on discretionary spending mandated by the Sequestration. At the same time, Congress is reviewing federal investment in Science Technology, Engineering and Mathematics education programs.

Several provisions of the America COMPETES Act will expire in 2013 and Congress has begun reviewing the contributions and opportunities made thus far from this Act. The celebrated Act provides funding for certain federal physical sciences and engineering research programs as well as selected STEM education programs. America COMPETES is important to funding institutions of higher education and other entities to pursuer research projects tied to the Advanced Research Projects Agency-Energy (ARPA-E).

Higher Education is of course a major area in the coming session of Congress. Congress is poised to consider the Higher Education Reconciliation Act (HEA) during the 113th Congress. Although, for the first time in many years, Michigan will not have a single representative on the House Education and Workforce Committee. However, there is still tremendous potential for Wayne State to educate Congress and the Administration on key policy area(s) including increasing undergraduate degree attainment and retooling investments in financial aid and higher education teacher preparation programs. APS is positioned to assist Wayne State on the Committee. We have worked with members of the Committee for decades and have proven results for our clients. While the specifics of the reauthorization are not complete, we know that stakeholders are working on behalf of their constituencies to educate Congress on what is important.
